**Bell Harbor Homeowners Association
Dockage Application & Agreement—2010**

The Bell Harbor Homeowners Association is vested with the authority to assign lift spaces for the commercial boat docks maintained and owned by the Association. Dockage assignments are to be completed by the Homeowners Association in January of each year for the upcoming summer season. Members of the Bell Harbor Homeowners Association must have all Annual Fees current through 2009 as a pre-condition of dockage approval. Homeowners utilizing dock services must have all **2010 fees paid prior to March 31, 2010**. (Please fill out a form for each space requested.)

NOTE: Only watercraft and boats registered and titled to Bell Harbor property owners will be allowed on Bell Harbor docks.
